#### **Chronic Health Effects**

Prolonged and repeated exposure to excessive airborne concentrations of talc can result in scarring of the lungs (pneumoconiosis) or the covering of the lungs (pleural thickening). Overexposure to sublimed zinc oxide may produce symptoms known as "zinc oxide chills" which have no recognized complications. Symptoms usually disappear within 24 hours. Fillers are encapsulated and not expected to be released from product under normal conditions of use.
