Hydrolytically stable and water repellent, TremPly® KEE FB Bonding Aahesive is self-curing, quick-drying and extremely strong. When applied properly, it creates a superior bond to the TremPly KEE FB membranes.

TremPly KEE FB Bonding Adhesive is used to adhere TremPly KEE FB membranes to approved substrates. Refer to current product listings for required wind uplift and fire rated systems.

The substrate must be smooth, dry, and free of debris or other irregularities; outside air temperature must be 40° F (4.4°C) and rising, but not higher than 90°F, while the adhesive is being applied. Approved substrates include preapproved gypsum-based coverbo; irds, polyisocyanurate insulation, and approved base sheets.

Roll or spray a smooth, even coat ofTremPly KEE FB Bonding Adhesive over the substrate at a coverage of approximatery 90 to 100 ft<sup>2</sup> per gallon (2.2 m<sup>2</sup>/liter). While the surface's porosity and smoothness will affect the actual coverage rate, it is critical to ensure 100% coverage.

Let the solvents dissipate so that the adhesive becomes sticky but not stringy to the. touch, then carefully roll in the TrernPly KEE FB membrane and broom the membrane in place. Do not allow the adhesive to "over cure" or dry out before rolling in the membrane.
